1. Call to Order at 6:30 p.m.

- **2. Approval of Agenda** The Board noted additional personnel for the consent agenda for this meeting. Motion by Harter, second by Anderson to approve the agenda as amended. Motion Carried 4-o.

- **4.1 Board Salutes TeamMates Mentors** The Board gave the TeamMates Mentors for the last school year a "Board Salutes" award. Dr. Hartman said that 30 mentors meet on a weekly basis during the second semester last school year. Four mentors received the Board Salutes at this meeting: Lisa Hartman, Kate Huse, Cindy Shelledy, and Hannah Swanson.
- **4.2 Liability & Property Insurance Coverage** Melissa Johnson of Midwest Insurance Consultants was present to discuss the 2018-19 liability and property insurance coverages for the District. She compared last year's insurance cost to this year's. This year's work comp cost was down and a reclassification of property in Nevada may also make impact on property coverage. She noted the coverage for violent event response: \$1 million. Overall, there was around a 1% decrease in premium for insurance.
- **4.3 Clarity Data** Mr. Gross reviewed the Clarity Data on the use of technology. Carrie Hillman, District Technology Integrationalist, started the Clarity Data survey when she came to the District. The survey reviewed the uses and integration of technology related to the "4Cs" of 21st Century Learning: Communication, Collaboration, Critical Thinking, and Creativity. Mr. Gross also distributed a draft of a rubric for collaboration in all the grades in the School.
