



Which of the Return-to-Learn options would you prefer for the beginning of the 2020-21 school year?

Guidance from local, state, and national health officials - 29.0%



Books or access to on-line books - 49.2%


Internet Access - 10.3%

Assigned seating, siblings/same household sitting together, and first-on-last-off protocols. - 28.4% Post-route disinfectant spraying. - 26.9%


Buses at half capacity with student and staff wearing masks/face shields - 17.2%

None of the above, I am not comfortable with my child(ren) riding a school bus. - 8.2%


Less than 17- on a 72- person capacity bus, less than 15 on a 65-person capacity bus. - 7.7%

Should the school district be aware of any underlying health conditions or other risk factors impacting your child's ability to attend on-site or hybrid learning this school year?







Should the school district be aware of any underlying health conditions, or other risk factors in your home impacting your child(ren)'s ability to attend on-site or hybrid learning this school year?
