- **4.1 Middle School Renovation Invision Architects** Architect Kerry Weig, via Zoom remote, reviewed the recent developments on the Middle School Renovation Project. The Project was put out for bids officially on Friday, November 13 and bids will be opened on December 10. The architect's plans are in the virtual plan room and have been reviewed by 36 contractors. The alternates to be bid on are the four the Board approved at their last meeting and the others listed as alternates previously discussed were incorporated into the project as needed. Ms. Weig reviewed the plans with the Board in detail.
- **4.2** Explorica Washington D C Trip Dr. Gray said that Mr. Hoffman, Middle School instructor, was working towards having a Washington, DC, trip for Middle School students in 2022. These trips are not school sponsored trips.
