- **2. Approval of Agenda** The Board noted additions for personnel to the agenda. Motion by Maier, 2nd second by Harter to approve the agenda as amended. Motion Carried 5-0

- **4.1 Middle School Renovation Update Estes Construction** For the renovation, Mr. Sharp noted that the vertical geothermal wells are ready and will have horizontal connections installed. He also reviewed the cost report for the project.

5.1 General Obligation Bond Bids

- a. Review General Obligations Bond Bids Piper Sandler Co Mr. Gillespie from Piper Sandler said that the District sold \$9,140,000 in general obligation bonds today for the Middle School Renovation Project. The company that bid the low interest rate on the bonds is Robert W. Baird & Company, Inc. of Milwaukee, WI. The weighted average interest rate cost of the bid from Baird is 1.012791% with interest rates on the individual bonds ranging from 1% to 1.1%. The last bonds mature in Fiscal Year 2030 with a call date on June 2026. Mr. Gillespie reviewed detailed results from the bond sale.
- **b. Resolution: Award of General Obligation Bond Bid** Motion by Anderson, second by Harter to approve the resolution to award the general obligation bond bid to Robert W. Baird & Company, Inc. Roll Call Vote: Chitty aye, Anderson aye, Harter aye, Maier- aye, Carsrud aye. Motion Carried 5-0

5.2 Sales, Service & Use Tax Revenue Bond Bids

- **a.** Review Sales, Services & Use Tax Revenue Bond Bids Piper Sandler Co Mr. Gillespie from Piper Sandler said that the District sold sales tax bonds to Luana Savings Bank, Luana, Iowa, for the District purchase of Gates Hall with an overall interest rate of 2.029443%. As a part of the purchase, old sales tax bonds with a principal of \$520,000 were refinanced and saved \$94,903 in interest.
