- **4. Public Hearing ESSER III Funding** No comments were heard during the public hearing of ESSER III Funding.
- **5.1** Middle School Remodel Update Estes Construction Mr. Sharp presented an update of the Middle School Remodel and his progress report was provided. Change orders to be approved by the Board were explained. Also, an update on the aluminum doors was provided.
