- **4.1 Middle School Renovation Estes Construction** Mr. Sharp gave the Board an update on the Middle School Renovation Project. He said the contractors are working on punch list of items yet to be completed. He complimented the Middle School staff for the patience with the project. One contractor is doing after-hours work for grinding and stripping the terrazzo floor. After Carsrud had asked about the main spaces yet to be finished up, Mr. Sharp said the administrative area was receiving paint on the ceilings and floors. In the commons area and kitchen, the ceiling and lights were being installed. Items being stored in the wrestling room would be moved to paint in that area. Additional work was being completed in the kitchen for the wet area in the dishroom. Aluminum doorway work would be in the first week of November by Reflections Glass. Mr. Sharp also reviewed the change orders to be approved by the Board in the consent agenda.
- **4.2 Student Achievement Data Dr. Kody Asmus** Dr. Asmus reviewed 2021 testing scores from this summer and fall which compared the data over those periods and compared those scores to the schools in the State and Heartland AEA. Dr. Asmus said the 20% of the summer school students were only present 90% of the time.
- **5.1 Modified Allowable Growth: Special Education** Motion by Chitty, second by Harter to approve requesting Modified Allowable Growth for the Special Education deficit from 2020-21 in the amount of \$258,033.99. Motion Carried 5-0.
- **5.2 Change of Policy 904.3** 1st **Reading** Dr. Gray requested that Board Policy 904.3 be changed to move the location to receive senior citizens' passes from the Superintendent's Office to the High School. Motion by Maier to approve the change to Board Policy 904.3 and to waive the second reading approval of that policy. Second by Chitty. Motion Carried 5-0
