

### Seeking 200 families to give \$200 a year

The City of Nevada recently announced the award of two large grants for the Nevada Field House, a multi-use, indoor recreational facility for all ages to be built at SCORE. The project was awarded a \$25,000 grant from the Story County Community Foundation and a \$424,000 State of Iowa Community Attraction and Tourism (CAT) grant. These two

grants bring the project much closer to the fundraising goal of \$7 million.

Upon receipt of these grants, the Nevada Foundation has begun a push for pledges totaling \$200,000 from the community. The Foundation is asking for 200 families to pledge \$200 a year for five years as part of this campaign.

"We are so very close to our fundraising goal on this project! We are thankful for the large amount of pledges and support that we have already received, and I know that the Nevada community will step up this month to get us across the finish line," said Michelle Cassabaum, who is chairing the fundraising campaign.

The Nevada Parks and Recreation Department is accepting applications for a variety of seasonal employment opportunities for the upcoming spring and summer.

**Aquatic Center:** Positions available for the Management Team, Head Guards, Lifeguards and Swim Lesson Instructors. If you are at least 15 years old by mid-May and are interested, consider taking the Lifeguard Training Class. Contact Nevada Parks and Recreation for training information. We will train the right candidate for any position.

**Concession/Cashiers:** Positions will work at both Fawcett Family Aquatic Center and the SCORE 4-Plex. Must be at least 14 years old by March 31.

**Umpires:** Youth baseball and softball umpires. Weekday evenings, April-early July. Plate umpires must be 16 years of age and base umpires 14 years of age to apply.



### American Rescue Plan Fund Awards

Story County was allocated \$18.9 million from the American Rescue Plan Act (ARPA). The Supervisors identified the best strategic uses of the funding to serve the citizens of the County to support the public health response, address negative economic impacts caused by the public health emergency, and invest in water, sewer, and broadband infrastructure.

Communities, organizations, external partners, and County departments were invited to submit proposals in the fall of 2021.

During several public worksessions, the Board determined the eligibility of the projects in accordance with the U.S. Treasury guidelines. Submitted applications focused on water quality and wastewater projects, affordable housing solutions, projects addressing negative economic impacts resulting from the COVID-19 pandemic (social service agencies, food insecurity programs and childcare), and projects addressing the public health response for the safety and accessibility of County operations.

### DO YOU OWN A WELL?

Story County Environmental Health recommends that private well owners, at a minimum, have their



well water tested annually for bacteria and nitrate levels. In addition, anytime a well owner experiences a power outage that lasts long enough for your water system to lose all pressure, the water should be tested once the power is restored.

Under our Grants-to-Counties Program, Story County residents can contact this office to set up an appointment for free private well water testing for any of the following: Coliform bacteria, nitrate, manganese, or arsenic.

# Looking to the Future

New master facilities plan includes enhancements to bring all health care services to Story Medical's South Campus

During 2021, the Story Medical Board of Directors and Senior leadership team began the process of developing a long-term plan for facilities. That planning included input from inside and outside the organization and has led to an ambitious vision that will transform the way residents of Story Medical Senior Care receive services, and further improve the care delivered to patients of the Medical Center and Nevada Clinic.

The plan calls for moving Story Medical Senior Care from its current location on 6th Street to the Story Medical South Campus on 19th Street, just south of Highway 30.

"Senior care is changing," Thompson says. "As the Baby Boomers age, they are wanting more from long term care. They want facilities that are comfortable and offer a variety of amenities. Additionally, it is important to offer convenient access to a full-service clinic and hospital care. The value that will come from our medical staff being essentially on-site is beyond measure."

A number of options for improving the environment of care at the current Medical Center are also being explored.

"Health care is always changing," Thompson says. "We have to be sure that we are able to meet the changing needs of patients. That requires the best technologies and the best support for our teams to ensure we can recruit physicians, nurses and great talent to this community."

"Our facilities are an important piece of that," Thompson continues. "With interest rates at an historic low, we are in a position to finance significant facility improvements without overburdening the local taxpayer."


Each building at Nevada CSD is spending time focused on developing the Social Emotional Skills of the adults and students in their building.

Central Elementary is in their 4th year of SEL, teachers are integrating SEL into teaching practices, teaching

direct SEL curriculum, as well as assessing student strengths to guide instruction.

At the Middle School, teachers are focused on SEL instructional practices and becoming more familiar with competencies.

At the High School, teachers this year are focused on Instructional Practices they can use in their space to support SEL development.

The USDA has issued nationwide waivers allowing schools to operate the Seamless Summer Option during the 2021-2022 school year.

Under the Seamless Summer Option, the Nevada CSD is pleased to offer a free breakfast and/or lunch each day to every student enrolled in Nevada.

Free and reduced meal application will not be necessary to participate in the Seamless Summer Option.

However, an application will be needed to waive school fees and for other benefits such as P-EBT. If your student is directly certified by the state and you would like to have your school fees waived then you will need to sign a waiver allowing your eligibility to be shared. ### Takin' it to the Street

You might have noticed some changes in the heart of Nevada, its main street, over the last two years. First the sign over 1015 6th Street changed to say Main Street Nevada, but what does this mean? In 2019 the Nevada Chamber of Commerce decided it was time to refocus and reinvent itself in pursuit of becoming a Main Street America community.

What is a Main Street America Community? In 1985, a national experiment started with three communities focused on starting reinvestment and reconnection to main street districts, and the businesses that call it home. Flash forward and the programs is composed of over 1,200 communities, with 54 in Iowa. To become one of these programs, communities must enter into a competitive application process. They must first complete a written application comprised of a broad base of community and city support, and then they must prove the commitment of the community for the program. They present before an in-person panel of judges. Only two programs are inducted every two years. Nevada and Coon Rapids, Iowa were the last two inductees. (in 2019.) We proudly support the Main Street Iowa and America initiatives, by implementing the Four Point Approach.





### Leadership Nevada



Leadership Nevada is a program of Main Street Nevada that offers the opportunity for participants to gain experience in civic leadership responsibilities and cultivate relationships with other local leaders and community members.

With these funds over 1.3 million dollars in capital have been committed to building rehabilitation in two years. Four large downtown events have been held bringing over 4,000 people to enjoy the district.

Under Steve's leadership, Main Street Nevada has grown to over 80 investor businesses, and has become a nationally recognized Main Street Program.

Steve will continue to be involved with Main Street activities as past president, and will continue to serve the community in a new role, as a city councilman.

### A familiar face at the helm

Stepping into the role of Main Street Board President is Lisa Oxley. Lisa has been involved in the Main Street Nevada effort since day one and has been critical in establishing a presence in the community for the organization.

As a 2003 graduate of Nevada High School, Lisa has called Nevada home for many years. Lisa's employer, State Bank and Trust, has been active in supporting the mission and vision of the organization, allowing Lisa the time to be active in Main Street.

Through strategic planning, Main Street Nevada has identified five areas of focus to drive events, business development, and growth: 1) Way-finding, 2) Increasing Membership, 3) Building Improvements, 4) More Volunteers, and 5) Small Business Development. These

### From the Director's Desk

Looking back on 2021 many amazing projects and steps forward were made in the Main Street District of Nevada. In one year we saw two full building rehabilitations receive grant funding, combined with local funds that generated almost 1 million dollars of committed investment in the district. The S.E. Briggs Block (Tipton's corner) received grant funding to assist in converting the now abandoned second floor into four quality apartments.

The second project is the Journal building project. Funding has been received to assist in converting the building into a possible restaurant/brewpub space, with offices and conference space in the lower level. The renovations will also include a historic tax credit qualified rehab, bringing the space back to a tribute of its original state, while using modern materials and furnishings. A rear courtyard with seating and room for socializing will also be part of the building project.

Work on the Union Block (Gatherings) project is approaching its final stage with drywall work wrapping up. The space will be home to a co-working area and conference rooms. The Union Block was the first grant-assisted project in the Main Street district, awarded in 2020.

2021 also saw the founding of the Camelot Theater Foundation, a group focused on the preservation and continued development of the Camelot theater, including building renovation and adaptive use of the lobby as a dining and event space.
