- **8.1 Middle School Renovation Update Estes Construction** Mr. Sharp said a punch list has been completed on the Middle School administrative area and commons. Aluminum door frames are to be installed starting November 22. There is work remaining in the kitchen and wrestling room. Clean-up remains in the unfinished areas. Mr. Sharp indicated that Estes may have to bring in supplementary companies to finish. For the two change orders to be approved: kitchen drywall work +\$7,537; wrestling duct, raise lights net change zero. Mr. Sharp said the wrestling room would be ready for use by early December.
- **9.1 SBRC Application for Modified Allowable Growth** Administration recommends approval the of the SBRC (School Budget Review Committee) Application. The District is eligible for \$208,620.80 of additional budget authority due to Open Enrollment Out added and not on the Fall 2020 listing and \$24,282.72 for ELL students who are with the District beyond five years. Motion by Maier, second by Harter to approve the SBRC Application for Modified Allowable Growth. Motion Carried 5-0
- **9.2 Consideration of Special Board Meeting, November 29** Dr. Gray asked that this item for a special Board meeting on November 29 be tabled. Guidance from the Iowa Association of School Boards has been received for the OSHA Mandate for the COVID vaccination. A lottery is being held to select judges to hear the stay on the OSHA requirements. Maier asked if weekly testing is the responsibility of employer. Dr. Gray said it is the employee's responsibility, to start December 6, with proof of immunization or testing.
