1. Call to Order at 6:30 p.m.

2. Approval of Agenda Motion by Anderson, second by Harter to approve the agenda as presented. Motion Carried 5-0

3. Public Comment - none

- **4.1 Social-Emotional Learning (SEL) Update Dr. Asmus & SEL Leaders** Dr. Asmus briefly reviewed the SEL program and the teachers on the team introduced themselves: Katie Borton, Randi Davis, Emily Kruse, and Emily Shuka. Initially, the Board was asked to review pictures as to where each person's feelings are tonight which was related to SEL. The team defined SEL and the SEL Vision for the District. By the 2024-25 school year, there will be a total integration of SEL in the schools. With the implementation plan, there are four legs: explicit instruction, culture and climate, integration, and parents & families. The Implementation Plan was reviewed for each building.
- **4.2** High School Course Description Guide 2022-23 Mr. Einsweiler The High School is preparing for the 2022-23 school year by reviewing the Course Description Guide for the students. Mr. Einsweiler reviewed the changes to be made in the Guide from 2021-22 and answered the Board's questions about the Guide.
- 5.1 Science Trip Proposal Mrs. Borton Mrs. Borton said she teaches freshman science which means she teaches all students. She said she took students on a science trip last summer which had been delayed to 2021 due to COVID. She said she is asking for permission to continue to take students on trips and get the word out to them. Dr. Gray said the trip is a trip outside of the School, but he requested that the Board approve the trips to publicize to them to students. The trips are not a school sponsored. Motion by Hayek, second by Maier to approve the science trips being proposed. Motion Carried 5-o.
- **5.2 Second Semester Course Addition: High School Talented & Gifted** Mr. Einsweiler reviewed the proposed course which is "TAG Student Interest Implementation", a one semester self-directed learning experience to help students develop individual aptitudes, talents, and passions. Motion by Maier, second by Harter to approve the addition of the TAG Student Interest Implementation course. Motion Carried 5-0
- **5.3 Policy Additions: OSHA** Employee Vaccination Requirement Dr. Gray said the proposed policy additions are required by OSHA for employee vaccinations. The court stay on the proposed policies has been lifted. Board Policy 209.2 "Adoption of Policy" allows the Board to approve policies required on emergency approval to meet required deadlines. Chitty said the requirement will be argued before the Supreme Court on Friday of this week.
