1. Call to Order at 6:30 p.m.

- **2. Approval of Agenda** The Board noted items to be added to the agenda for the Middle School Renovation Project. Motion by Anderson, second by Hayek to approve the agenda as amended. Motion Carried 3-0
- 3. Public Comment none
- **4.1 Board Salutes Nevada Music Parents** The Board Salutes was awarded to the Nevada Music Parents for their work in the concession stand for a fundraiser for the Music Department.
- **4.2 Middle School 5-8 Math Pathways Mr. Sneiderman & Dr. Asmus** Mr. Sneiderman reviewed the current Middle School Grades 5-8 Math Curriculum. He said the math program has been self-paced for seven years and students worked at their own pace. Mr. Sneiderman said, when the assessments were reviewed, they showed proficiency flat or down and risk indicators going up in math. He said self-paced works best in 90 minute blocks and the self-paced program is quick completion rather than mastery. After COVID, a teacher-paced math program was used and FAST data is trending up this school year.
- Dr. Asmus and Mr. Sneiderman proposed a new pathway for grades 5-8 math: continue self-paced work with more teacher direction. This pathway will better transition students from Elementary and to High School. Students who are struggling would receive needed help. The pathway would be compact: all students completed 5th grade math with help for the new transition; 6th grade would cover all of the 6th grade course plus 7th grade standards; 7th grade would cover the remaining 7th grade standards and all of 8th grade standards; and 8th grade can then take High School Algebra. Mr. Sneiderman reviewed staff input, compact pathway criteria and "What Ifs".
- **5.1 NCRC Handbooks 2022-23** Mrs. Burling reviewed the handbooks for the Nevada Community Resource Center (NCRC). She said the rate for students will increase rate by \$5.00. For the first time since COVID, the summer program will be doing field trips this year. The summer program for this year is full so there has been collaboration with other daycare program. The summer program will be held at the Elementary. Motion by Anderson, second by Hayek to approve the NCRC 2022-23 Handbooks. Motion Carried 3-0
- **5.2 Renewal of Sharing Agreements 2022-23** Dr. Gray review the sharing agreements held with other school districts, specifically Colo-NESCO and Baxter. Motion by Hayek, second by Anderson to approve the sharing agreements for 2022-23. Motion Carried 3-0
- **5.3 Athletic Co-op High School Girls' Wrestling** Girls' Wrestling will be sanctioned by the Iowa Girls High School Athletic Union next year. A partnership between Nevada (host), Ballard, Collins-Maxwell,
