- 1. Call to Order at 6:36 p.m.
- **2. Approval of Agenda** The Board noted addition personnel for the consent agenda. Motion by Harter, second by Maier to approve the agenda as amended. Motion Carried 3-0
- 3. Public Comment none
- 4. Public Hearing on 2021-22 Budget Amendment
  - **4.1 Presentation** As published in the *Nevada Journal* on Thursday, May 6, this was the time for the hearing on the Fiscal 2021-22 Budget Amendment. Schaeffer reviewed the changes:
  - **For Total Support Services:** From \$7,573,635 to \$7,873,635 to allow for the expenditure of COVID-19 funds (ESSER) from the Federal Government;
  - For Noninstructional Programs: From \$800,000 to \$1,000,000 to allow for additional food service costs;
  - **For Total Other Expenditures:** From \$10,166,658 to \$10,466,658 to allow for additional Middle School Project expenditures.
    - **4.2 Public Comment** No public comments were received for or against the budget amendment.
    - **4.3 Approval of the Budget Amendment** Motion by Maier, second by Harter to approve the Fiscal 2021-22 Budget Amendment. Motion Carried 3-0.
- **5.1 Building Handbooks 2022-23** The building principals reviewed each of their handbooks. Student Board Member Ben had adjustments for handbooks for the Middle School and the High School.
- **5.2 IASB Policy Additions first reading** The Board reviewed the proposed addition of the following Board policies:
  - 710.1E1 School Nutrition Program Notices of Nondiscrimination
  - 710.1E2 Child Nutrition Program Civil Rights Complaint Form
  - 710.1R1 School Nutrition Program Civil Rights Complaints Procedures
- **6.1 Nutrition: Meal Prices 2022-23** Ms. Veach said she was recommending an increase 25 cents for all meals for 2022-23. She said this was due to the following: 1) current federal waiver for free meals ends on June 30; 2) the federal reimbursement rate decreases; and 3) food costs are increasing. Motion by Maier, second by Harter to increase meal prices by 25 cents for the 2022-23 school year. Motion Carried 3-0
- **6.2 Nutrition: Milk & Bread Renewals 2022-23** Ms. Veach said she had requested prices from Rotella Bakery for baked goods and AE Dairy for milk services. She said she reviewed the pricing and

recommends that the contracts with both Rotella and AE be renewed for 2022-23. Motion by Harter, second by Maier to approve the contracts for food products for Rotella and AE for 2022-23. Motion Carried 3-0

- **6.3 Nutrition: AEA Purchasing 2022-23** Ms. Veach had been using a local food products cooperative for supplies for the District meals. Administration is recommending that the District return to the AEA Purchasing Coop for these supplies for 2022-23. Motion by Harter, second by Maier to approve the AEA Purchasing Agreement for 2022-23. Motion Carried 3-0
