- 1. Call to Order at 6:30 p.m.
- **2. Approval of Agenda** The Board noted an additional fundraiser to be added to the consent agenda. Motion by Anderson, second by Hayek to approve the agenda as amended. Motion Carried 4-0
- 3. Public Comment none
- **4.1 Middle School Renovation & Completion Update** Mr. Kroese reviewed information from the Middle School Renovation Project. He said an official completion date is still to be determined. He noted that the Middle School was declared "substantially complete" in 2021 when students and staff moved in to the Middle School. He said the "warranty walk" will be coming next week with all contractors invited to review warranty items on their coverage. Mr. Kroese said the students and staff are in a safe environment but some facility items are missing. The final punch list of items will come soon. In the summer, items to be completed by staff will be undertaken.
- **5.1 SBRC Applications for Modified Allowable Growth** This is the annual application for Modified Supplemental Amount (Spending Authority) for the items below:
- **a. Open Enrollment Out Not on Prior Year Count** 24.3 students were open enrolled out that were not on the prior year's count: 24.3 students x \$7,227 prior year's District Cost Per Pupil (DCPP) = \$175,616.20.
- **b.** Limited English Proficiency (LEP) Instruction Beyond 5 years 14 students LEP beyond five years were counted: 14 students x .21 weighting x \$7,413 current DCPP = \$21,794. Motion by Harter, second by Anderson to approve the entire SBRC Application for Modified Allowable Growth. Motion Carried 4-0
