1. Call to Order at 6:30 p.m.

- **2. Approval of Agenda** The Board noted additional fundraisers and early graduations for the consent agenda. Motion by Anderson, second by Harter to approve the agenda as amended. Motion Carried 5-0
- 3. Public Comment none
- **4. Public Hearing** Legislative House File 565 (2017) set up a flexibility fund to receive transfers from categorical fund balances and/or a discontinued funds. This hearing is being held on a resolution to expend funds from the district's flexibility account for General Fund purposes. These funds were unexpended and unobligated from the following sources: Home School Assistance (\$109,906.41) and Mentoring (\$7,622.41). Notice was published in the Nevada Journal on Thursday, October 5 that this is the time and the place for the Public Hearing on the Flexibility Fund request.

Chitty opened the public hearing on the Flexibility Fund transfers and, hearing no comments from the public, closed the hearing.

- **5.1 Resolution Directing Expenditures of the School Flexibility Fund** Schaeffer reviewed the Flexibility Fund request. Dr. Gray noted that some of the balance in the Home School Assistance Program occurred prior to the program was .6 changed to .3 per student. Motion by Anderson, second by Maier to approve the Resolution Directing Expenditures of the School Flexibility Fund. Motion Carried 5-0.
