- 1. Call to Order at 6:30 p.m. by Vice-President Tom Maier
- **2. Approval of Agenda** The Board noted additional personnel for the consent agenda. Motion by Harter, second by Anderson to approve the agenda as amended. Motion Carried 4-o
- **3. Public Comment** Dr. Gray noted a letter that the Board received from the Vier family expressing support for a School Resource Officer (SRO) to be present in the District's facilities. Dr. Gray said that a joint City-School meeting was scheduled for next week and this item will be added to the Board Retreat agenda in a month.
- **4.1 Mr. Cooper FFA** A 2015 will provided by an attorney representing Wilma Longnecker was to bequest 230 acres to the Nevada FFA. Mrs. Longnecker died on December 23, 2023. Her stepson has now produced will created in 2023 where the Nevada FFA not listed as beneficiary. The District will contact the attorney and wait for decision on wills. Mr. Cooper also reviewed the FFA's activities over the past few months.
- **5.1** Annual At-Risk/Dropout Prevention Plan Review Dr. Gray presented an updated At-Risk/Dropout Plan and requested Board approval of this document. Motion by Hayek, second by Harter to approve the updated At-Risk/Dropout Plan. Motion Carried 4-0
- **5.2 At-Risk/Dropout Modified Supplement Request** The annual request for the Modified Supplement Request amount for At-Risk/Dropout was presented. This amount is \$477,783 for the 2024-25 school year. Schaeffer explained the request and noted that District would be responsible for 25% of this amount, or \$159,261. Motion by Harter, second by Anderson to approve the At-Risk/Dropout Modified Supplement Request for \$477,783. Motion Carried 4-0
- **5.3 SBRC Application for Woodward Academy & Grandwood Costs** The Woodward-Granger District is requesting that the District approve the SBRC Administrative Costs for 2024-25 for students Nevada sends to the Woodward Academy & Grandwood programs. Motion by Hayek, second by Anderson to approve the SBRC Application for Woodward Academy (\$3,355.23) and Grandwood (\$3,893.97) Administrative Costs. Motion Carried 4-0
- **5.4 IASB Policy Primer First Reading** Several Board policies were added and adjusted with the latest IASB Policy Primer. Two policies were added: 605.8 "Artificial Intelligence in the Education Environment" and 605.8R1 "Artificial Intelligence in the Education Environment Regulation". Policies updated included 502.7 "Student Substance Abuse", 701.3 "Financial Records", 701.4 "Governmental Accounting Practices & Regulations", and 703.1 "Budget Planning". Current policies 605.8 "Use of Information Resources" (new 605.7) and 605.7 "Musical Display Night" (new 605.9) will be moved.
