1. Call to Order at 6:30 p.m.

- **2. Approval of Agenda** The Board noted an additional appointment for the consent agenda for this meeting. Motion by Harter, second by Maier to approve the agenda as amended. Motion Carried 5-0
- 3. Public Comment none
- **5.1 Fuel Tax Removal Quotes** Mr. Sampson said that the District has received four quotes for removal of the fuel tanks at the Bus Barn. The lowest, \$15,800 from Unified, is recommended for approval. Administration will also apply for a \$15,000 grant from the Iowa Department of Natural Resources Underground Storage Tank Fund. Mr. Sampson the tanks will only be removed at this time. The tanks are fiberglass and are 37 years old. The maximum life on the tanks is 40 years. The insurance currently held on the underground tanks would end. Removal work would be completed during the summer. Quotes will be taken soon to upgrade to two 1,000 gallon tanks. Motion by Maier, second by Anderson to accept the low bid for tank removal of \$15,800 from Unified. Motion Carried 5-0
- **5.2 Gates Conference Room Remodel** Nevada Parks & Rec have now moved out of the northeast offices at Gates Hall. Using the remaining Gates Hall remodel funds, administration would like to remodel this area into a conference room and storage. The current auditorium can be used as a conference room but it is used frequently. Asbestos needs to be removed on the floor which will be contracted out. Student Board member Taylyn said it would be nice to have a smaller testing space at Gates. Motion by Hayek, second by Harter to approve the Gates Hall remodel for a cost of approximately \$35,900. Motion Carried 5-0
- **5.3 Wrestling Mat Quote** The Athletic Department is recommending the purchase of a wrestling mat to be reimbursed by the Booster Club for \$14,350. Motion by Anderson, second by Harter to approve the purchase of the wrestling mat. Motion Carried 5-0 Chitty thanked the Booster Club for the contribution to make this purchase.
- **5.4 Security Quote Technology** Mr. Wakeman said he was requesting approval of a quote to upgrade security to a card entry at the doors to work directly with security camera system at both Gates Hall and the Resource Center. The quote for this is \$22,777. For the Gates portion, the funds will come from the Project budget and, for the Resource Center, funds will come from the tech budget. Motion by Hayek, second by Maier to approve the security technology bid from ByteSpeed for \$22,777. Motion Carried 5-0
