1. Call to Order at 6:30 p.m.

**2. Approval of Agenda** Motion by Harter, second by Hayek to approve the agenda as presented. Motion Carried 5-0

## 3. Public Comment - none

- 4.1 FY25 Budget Presentation Brian Schaeffer, SBO Schaeffer presented the Certified Budget Proposal for 2024-25 which assumes 2.5% Supplemental State Aid (SSA) as the Legislature has not set State Aid yet, but deadlines for reporting the total levy to the Iowa Department of Management are in March. The deadline is March 15 for the data the new Taxpayer Statement to be mailed out by the County Auditor after that date. Schaeffer reviewed "School Finance 101", the District enrollment, the SSA, the Authorized Budget, revenues, expenditures, financial condition, and the proposed levy. Schaeffer was proposing a total levy of \$13.34 per thousand taxable valuation, down from this year's levy of \$14.70, due to the debt service levy decreasing by \$1.30.
- **5.1 Levy Determination for Taxpayer Statement** Schaeffer asked the Board to set a total levy for 2024-25 so the information could be provided to the Iowa Department of Management for the Taxpayer Statement to be distributed by mail. The Board discussed the levy and adding to the levy for wage adjustments and the proposed school resource officer. Motion by Harter, second by Hayek to set the total levy, for now, at \$ 13.57 for the Fiscal Year 2025 Taxpayer Statement. Motion Carried 5-0
- **5.2 School Safety Improvement Grant Quotes** Mr. Wakeman presented quotes from contractors for the School Improvement Safety Grant. The low bid is from ByteSpeed which will partially be covered by the School Safety Improvement Safety Grant of \$150,000. Mr. Wakeman said the improvements will cover a majority of blind spots in all three buildings and improve building access safety. With this update, the tech is better and is at a reasonable price. Door position sensors will be used and will send out alerts for those propped open or unlocked. Motion by Maier, second by Anderson to approve the school safety grant quote from ByteSpeed of \$206,178. Motion Carried 5-0
- **5.3 Policy Review** Motion by Maier, second by Harter to approve the review of Board Policy series 900 series, Policy 405.8 "Licensed Employee Evaluation" and Policy 501.3 "Compulsory Attendance". Motion Carried 5-0
- **5.4 Policy Updates 405.2 Licensed Employees** For the revision and approval of Board Policy 405.2 "Licensed Employee Qualifications, Recruitment, Selection", only the reference to "TeachIowa", the old website for education jobs, was removed. Motion by Hayek, second by Anderson to approve the first reading of Board Policy 405.2 "Licensed Employee Qualifications, Recruitment, Selection" and waive the second reading. Motion Carried 5-0
