Are you ready for Nov. 5, 2024? There are two questions you should ask yourself to prepare for the upcoming presidential election.

### Question 1: Am I registered at my current address in Story County?

If the answer is 'Yes,' move on to Question 2. If the answer in 'No' or 'I don't know,' it is easy to register. Here are some options:

- Complete Story County's fillable, postage-paid registration form. Print, sign, fold, and mail: <https://tinyurl.com/59jcbzwu>.
- Register online (Iowa driver's license or Iowa non-operator ID required): <http://bit.ly/2cMYxIk>
- Use [voterready.iowa.gov](http://voterready.iowa.gov) to register (paper and electronic options available).
- Call the Auditor's Office and request that we mail you a voter registration form: 515-382-7210.

However you choose to register, the pre-registration deadline is Oct. 21 at 5 p.m. Mailed forms must be postmarked no later than this date. It is highly recommended that you pre-register to vote. After Oct. 21, election day registration regulations apply.

### Question 2: Do I know the location of my polling place?

If the answer is 'Yes,' you are ready to go to the polls on Nov. 5.

If the answer is 'No,' or 'I'm not sure,' here are a few different ways to find the answer.

- Check the polling place information listed on your voter card.
- Enter your street address into our polling place lookup site: [apps.storycounty.com/electionpollingplace/](https://apps.storycounty.com/electionpollingplace/).
- Call the Auditor's Office and give us your address: 515-382-7210.

That's it! You are prepared for the Nov. 5, 2024 election. Happy Voting!

## PLACES TWO 'HOMES FOR IOWA' IN STORY COUNTY

The Story County Housing Trust (SCHT) is a 501(c)(3) non-profit organization and is designated by the Iowa Finance Authority as the Local Housing Trust Fund for Story County. The goal of the SCHT is to improve affordable housing in Story County.

Through the Story County American Rescue Plan Act (ARPA) program, SCHT is working to not only provide funding to

first-time home buyers, but work with local communities in Story County to purchase, site, and sell Homes for Iowa houses. SCHT is currently placing two homes, one in Nevada and one in McCallsburg. Both are under construction.

## Prepare now for 'colder weather' emergencies

September is Emergency Preparedness Month.

Story County Emergency Management suggests people should prepare an emergency kit with at least three days of supplies for you, your family and your pets.

Basic Emergency Supply Kit:

- Water and food for three days
- Flashlight and batteries
- Clothing
- Personal hygiene items
- Cell phone
- Battery operated radio
- First-aid kit
- Bedding
- Money
- Copies of important documents such as drivers' licenses, birth certificates, insurance and other financial information
- Specialty items such as formula, diapers, medications and pet supplies

## Property taxes due September 30

Story County property taxes are due on or before Sept. 30, 2024. Sept. 30 is a Monday this year. Property taxes must be paid or postmarked by Sept. 30, 2024 to avoid late penalty. Taxes paid after Sept. 30 will be assessed a 1.5 percent penalty and accrue an additional 1.5 percent penalty on the first of every additional month until they are paid.

Treasurer's Office is open Monday-Friday from 8 a.m. to 4:30 p.m. (except for the second Tuesday of each month, when they are open from 9:30 a.m.-4:30 p.m.)

# Nevada Man Says Stroke is No Joke

Dave Whitney gains appreciation for local care team after medical emergency

When Dave Whitney went to bed on April Fool's Day, nothing seemed amiss. When he woke the next morning his life had changed dramatically.

Dave suffered a stroke in his sleep, a shocking discovery for a man who, at 61, had never been on any maintenance medication. He had no symptoms and even his last physical a couple years prior showed a blood pressure most men his age range would take in a heartbeat.

But none of that mattered as his neighbor rushed him to the Story Medical Emergency Department.

"Nothing had changed in my eating habits or my lifestyle," Dave says. "I had worked my whole life and considered myself to be as healthy as anyone else."

Truly, the stroke struck without warning. Upon his arrival at Story Medical, Dave was immediately assessed and stabilized.

"I was kind of in a fog, but I know they had like five or six people checking on me," Dave recalls, emphasizing the prompt and thorough care he



received. "The medical team was quick to act, performing scans and giving me medication to manage my blood pressure which was very high."

Once stabilized, Dave was admitted to the Inpatient Unit at Story Medical. His two-week stay was unexpected but crucial in building a solid foundation for his recovery.

"For me to be there two weeks, I think I was pretty bad off," he admits. "But despite how bad it was, my experience was exceptional. All the people there were fantastic."

In addition to 24/7 care on the Inpatient Unit, Dave was able to begin his rehabilitation while still in the hospital. By the third day, Dave was already participating in therapy sessions facilitated by 21st Century Rehab.

Rehabilitation was no easy feat; Dave spent the initial days largely confined to his bed, grappling with the loss of function on his left side.

"The left side almost immediately started getting just a little bit better," he says, highlighting the gradual but positive progression in his recovery. "My therapy sessions were tough, but very rewarding. It wasn't long before I could walk a short distance without a cane."

Now a few months removed from the unexpected hospital stay, Dave is continuing his recovery. He continues to attend physical therapy sessions at 21st Century Rehab, focusing on regaining strength and mobility.

"I'm still going for occupational therapy, working on my left hand and my shoulder," he says. "I am so thankful for the comprehensive care I get from the team at 21st Century Rehab and Story Medical."

Reflecting on his treatment and recovery, Dave expresses immense gratitude for the proximity of such high-quality care.

"The fact that I was able to stay close to home, instead of going to a larger city, was a huge weight off my shoulders," Dave says. "A lot of people think it is an advantage to be at a big hospital in a big city. I look at it the other way. Being at a smaller hospital meant that I got a lot more attention. That was important to me."

"And one other thing," Dave adds with a smile. "It may sound cliché, but the food there was great. I wouldn't recommend it as a vacation spot, but all in all, I had a very pleasant stay, and I appreciate the kind of care I was provided."

## RECOGNIZING THE SIGNS OF STROKE

The acronym **FAST** is a quick guide to recognizing the symptoms of a stroke, where each letter represents a specific area to check:

- **Face:** Check for drooping on one side of the face. Ask the person to smile to see if one side of the face hangs downward.
- **Arms:** Ask the person to raise both arms. Does one arm drift downward, or is one arm unable to rise?
- **Speech:** Listen for slurred or strange speech. Ask the person to repeat a simple sentence and see if they can do so accurately.
- **Time:** If you observe any of these signs, call emergency services immediately. Quick action is crucial in treating stroke effectively.

# Verbio launches ethanol production at its biorefinery plant in Nevada

Verbio has commenced the commercial production of corn-based ethanol at its biorefinery facility in Nevada. The plant, a subsidiary of Europe's leading biofuels and bioenergy producer Verbio SE, underwent a thorough commissioning process over the past six months resulting in the successful start of bioethanol production.

The completion of this second phase of the Nevada plant's strategy in the US market is the next milestone for the company. Operating as a full biorefinery, Verbio has installed a total capacity to produce 60 million gallons of corn-based ethanol per year and 2.3 million MMbtu of renewable natural gas (RNG).

"The start of ethanol production, in addition to our industrial-scale RNG operations since December 2021, means a landmark moment for us at Verbio," stated Verbio CEO Claus Sauter. "Bioenergy as a growing global market plays

a fundamental role in the transition toward sustainable mobility by providing RNG for transportation fuels, as well as for industrial and commercial uses."

## NEW REVENUE STREAM FOR GROWERS AND ADDED VALUE FOR THE REGION

The production in Nevada added eight additional fermentation tanks, new equipment, a corn unloading facility and silo storage, as well as close to 50 full-time jobs. To secure feedstock for RNG and ethanol production, Verbio collaborates with local growers in the region. "By buying not only their ag residues, but as of now, also their corn, we are able to provide growers with additional revenue streams for their businesses. Our goal is to bring added value to the region. The sustainable production cycle we use at Verbio allows us to sell back high-quality co-products from our production, such as humus, two differ-

ent soil amendments and corn oil," explains Greg Faith, Verbio Nevada plant President and General Manager.

Verbio Nevada is the first industrial-scale plant in North America coupling RNG and bioethanol production. The Nevada, Iowa plant has been converting corn stover to RNG since 2021. By using an innovative biorefinery concept, Verbio is now able to expand its operations to the next level. This additional process combines both bioethanol and associated biomethane production from corn stillage, a by-product from the ethanol production. The interaction of RNG and ethanol production, unique to the Verbio brand, incorporates advanced technology developed and successfully used for more than a decade at the company's facilities in Germany. Globally, Verbio now operates three biorefinery plants based on the bioethanol-RNG concept and four stover based RNG plants.

# Saving Lives

## FIRE DEPARTMENT SCORES GRANT FUNDS FOR CARDIAC MONITORS

The Nevada Fire Department and EMS team has become quite adept at securing grant funds to help pay for the many devices and necessities it takes to keep this community safe.

At the July 22, 2024, City Council Meeting, Assistant Chief and Paramedic/Nurse Jeff Gilchrist told council members how a \$15,000 grant from Prairie Meadows has allowed the department to secure new cardiac monitors, which are vital to helping a person in the midst of cardiac arrest.

According to the National Heart, Lung and Blood Institute, nine out of 10 people who have cardiac arrest outside of a hospital die. Residents of Nevada, however, have a greater chance of surviving one of these episodes due to the paramedic-level personnel and equipment offered by our volunteer fire department.

"In 2018, I approached Chief Reynolds with the idea of getting an EKG monitor that offered a multi-view of the heart and would help identify heart attacks," Gilchrist said. A gift from Mary Greeley Medical Center equipped the department with two monitors at that time. "Those monitors served us well," Gilchrist said, "...but they aren't being serviced anymore for parts, and we aren't sure how much longer they will work for us."

Department Lieutenant and Paramedic Ray Beaty saw that Prairie Meadows was taking applications for grants, but at the time he saw it, the department had only seven days to get an application in.

"I am now retired for the most part," Beaty said, "so I have some time to work on grants." He immediately went to work on the Prairie Meadows grant and was able to get it.

With the help of the grant award and a 50/50 percent partnership match from the City and the Nevada Fire Association\*, the Nevada Fire Department now has two new LIFEPAK 15 Monitor/Defibrillators. Valued at \$30,000 each, "these have a lot of capabilities," Gilchrist noted.

One of the monitors will be kept in the vehicle of the Fire Chief, who is often first on scene during daytime emergencies. The other will be kept in the department's EMS vehicle.

Beaty said there are some grants you get, some you don't, but he's very happy he was able to secure the Prairie Meadows grant.

"Fire and EMS departments rely on grants to help fund fire and medical equipment as cities are facing budget restraints," he said.

Fire Chief Ray Reynolds commended Beaty and Gilchrist for their continued work on behalf of the department. "The leadership in our EMS section is strong and you are directly responsible for our continued success."

The department has already experienced the joy of saving lives with its paramedic-level staffing and equipment. Reynolds wondered, as he considered the department's training and new equipment, "how many lives will be touched?"

## PUBLIC HAS 60 DAYS TO CLAIM

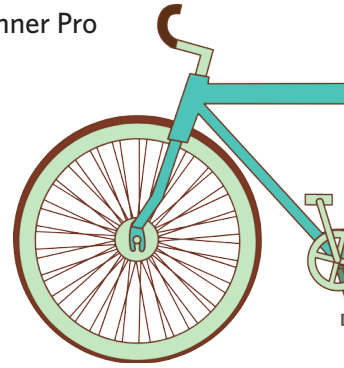

## Q&A with Director of Public Safety about stop signs and speed limits

### **A new 4-way stop sign will be placed at the corner of Sixth Street and E Avenue. Why is this needed?**

Part of what the Public Safety Department does is monitor trends and try to improve the safety of the roadway. This can be anything from increased patrol and enforcement in areas of concern to recommending changes to what is currently in place. In this case, we have seen a drastic increase in the number of motor vehicle accidents at 6th Street and E Avenue. Many of these accidents are caused by traffic on E Avenue attempting to cross 6th Street and not having time and space available.

In this area, traffic usage on 6th Street has increased in 2024. This may be related to the new S-14 flyover bridge. The number of accidents warrant some form of modification. A stop sign will allow vehicles on E Avenue that are traveling east or west to be able to safely navigate the intersection. In addition, we have seen a backlog of vehicles attempting to turn east or west off of 6th Street. The stop sign should also provide a consistent opportunity for those vehicles to turn safely.

**When will the additional stop signs go up?** The 3rd, and final reading of the ordinance is Aug. 26. The ordinance should be published shortly after that and the signs should then be posted.

**The speed limit between E Avenue and I Avenue on Sixth Street is going to be reduced from 35 mph to 25 mph. Why is this necessary?** Knowing all motorists will be stopped at 6th Street and E Avenue, the consideration for 6th Street between E and I Avenue's speed allows for modification. Most residential areas are 25 mph (Lincoln Highway being 30 mph is the only variation). Knowing everything between E Avenue and I Avenue is residential, as well as the future growth in number of residents with the remodel of the old Story County Long Term Care facility, suggests the same speed limit. In addition, going from a stopped position at 6th Street and E Avenue, or traveling south from a stopped position at 6th Street and I Avenue, the vehicles would be accelerating to 35 mph over a short distance and then coming to an additional stop. The 25 mph limit allows for a slower increase in speed, thus allowing for quicker reaction time by the driver in the event a pedestrian was to enter the roadway.

**When will the new speed limit go into effect?** The 3rd, and final reading, will be on Sept. 9. The ordinance should be published shortly after that and the speed signs replaced.

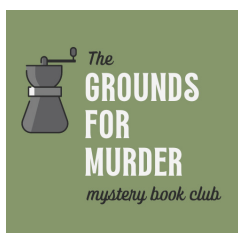

# New small business attraction funding announced

The City of Nevada, along with Main Street Nevada and the Nevada Economic Development Council, is pleased to announce a new funding program designed to support the attraction and expansion of small businesses within the community.

The goal of the "Revitalize Nevada Business Grants for Job Support, Growth, and Development" program is to encourage new businesses to locate within the city limits of Nevada, ultimately supporting job creation and business attraction and retention in the community.

The Nevada City Council and the Nevada Economic Development Council will provide funding for the program. Each organization is committing \$10,000 from their current budgets to support the new program. The program's utilization and effectiveness will be evaluated early next year to determine whether additional funds will be directed to it.

Applicants must provide a letter of interest along with a well-detailed business plan, including an executive summary of the business idea, market analysis and an overview of competitive strategy, operations, and management detail, and a financial overview (list of the financing sources, proposed start-up budget, and projected cash flows for the first two years).

Mayor Brett Barker explained, "We are excited to launch this new program to support the attraction of new business to Nevada as well as support the expansion and diversification of our existing small businesses. We are grateful for the partnership we have with both Main Street Nevada and the NEDC."

## Grant funds can be used for the following:

- Capital expenditures related to the purchase of a building in Nevada
- Building improvements (structural or aesthetic)
- Expenses relating to the purchase of machinery, equipment, or tools needed to operate the business
- Marketing or advertising campaigns
- Signage
- Utility expenses

## The grant cannot fund:

- Payroll or employee compensation
- State, local, or federal tax obligations
- Fines related to health or safety violations

Because funds are limited, special consideration will be given to business prospects looking to start up one of the following businesses in Nevada:

- Restaurant, Deli, or other retail food service
- Recreational or entertainment venue
- Sporting goods, crafts, or hobby
- Product niche and/or gift store

Grants will be issued at a maximum of \$5,000 each. The funds are available until they have been exhausted for the current fiscal year.

# Returning to Nevada

*Attention Nevadans:* Just like the lyrics to the 1978 song, it "Looks like we got us a convoy!"

That's right, a convoy of military vehicles traveling the historic Jefferson Highway route, will be coming through Nevada in October, according to organizers John Varner and Charles "Chuck" Toney.

**"We will be stopping for lunch in Nevada on Wednesday, Oct. 9," Toney confirmed.**

Some residents may remember that this same group of military vehicles, MVPA (Military Vehicle Preservation Association) Convoy, traveled the Lincoln Highway and came through Nevada during the 2019 Lincoln Highway Days celebration (as pictured above). The timing was purely coincidental, but because they were coming through town, they joined in the Lincoln Highway Days parade that year, making it even bigger than usual.

"This is our 7th transcontinental convoy, and the first along the Jefferson Highway," Varner said. Along with the Lincoln Highway, which the group has traveled twice, other highways traveled include the

BankHead Highway, the Alaska Highway, Route 66, the Yellowstone Highway, and the NW Pacific Highway in 2022 (which was not a transcontinental trip).

The convoy coming through Nevada this October will be traveling from the US border with Canada to New Orleans to celebrate and boost the original Jefferson Highway National Route. Varner and Toney expect 35 to 45 historic military vehicles and 85 to 100 people to be part of it.

"Stopping in small towns and meeting fellow Americans in order to display our historical military vehicles and to honor all veterans," Toney said, are the things participants enjoy most. "One does not really know and understand our great country until one drives around 30 mph down historic backroads, where you can hear the cows 'moo' and the children laugh, and meet every-day Americans in their hometowns."

Varner and Toney hope Nevada residents will take time to visit with them in front of City Hall as they pass through the community. To talk with members of the
